Conflict of Interest Disclosures

The American Academy of Hospice and Palliative Medicine (AAHPM) requires authors, reviewers and editors to disclose possible conflict of interest situations (financial or personal interests), real or apparent, that may affect or appear to affect the impartiality and the integrity of the peer review process of its journal, the *Journal of Pain and Symptom Management (JPSM)*. Editors will be excluded from the review process if it is determined that they have a potential conflict of interest. The disclosure of a potential conflict of interest does not necessarily exclude an article from consideration for publication; the goal of disclosure is transparency.
