## Maintenance of Certification (MOC) Points

The 2025 Annual Assembly of Hospice and Palliative Care is planned in the context of one or more of the ABMS/ACGME Competencies and includes an evaluation designed to assess changes in learners' competence, performance, or the impact on patient outcomes.

AAHPM has registered the 2025 Annual Assembly of Hospice and Palliative Care to offer MOC points to the following certifying Boards:

- **American Board of Anesthesiology:** This activity contributes an anticipated 45 CME credits\* to the CME component of the American Board of Anesthesiology's redesigned Maintenance of Certification in Anesthesiology™ (MOCA®) program, known as MOCA 2.0®.

## RN and APRN Nursing Continuing Professional Development (NCPD) Contract Hours\*
