Submitters to the Principal Call are strongly encouraged to incorporate one or more of the following cross-cutting themes. These themes play a key role in shaping the structure and flow of the Annual Assembly program by informing placement of accepted presentations. They help ensure alignment with audience needs, conference priorities, and balance across disciplines, settings, and topic areas.

• Justice, Equity, Diversity, and Inclusion (JEDI):

The abstract meaningfully addresses issues of diversity and representation, particularly related to historically marginalized or minoritized populations, and is grounded in principles of equity and inclusion.

• Interprofessional and Multidisciplinary Collaboration:

The abstract highlights collaborative approaches across disciplines that significantly influence hospice and palliative care practice, team-based care, or interprofessional learning and development.



### **Principal Call Presentation Format**

Submitters will be considered for **Podium (Oral) Presentations**.

The Co-Chairs and Planning Committee determine the final presentation length based on reviewers' scoring outcomes, knowledge or skill needs, committee recommendations, successful mitigation of conflicts of interest (where applicable) and overall programmatic needs of the Assembly.

### **Principal Call Submission Timeline**

- Submission Deadline: Monday, July 14, 2025 at 11:59PM PT
- Notification of Acceptance: The week of September 22, 2025

### Please Note New for 2026

- The Principal Call is only open to Podium presentations across the defined tracks noted above.
- The Scientific Research Call for Abstracts will be part of a Subsequent Call, opening mid-September 2025. This is a change from previous years.

# For Planning Purposes: Upcoming Subsequent Call for Abstracts will be open from September 25, 2025 through October 12, 2025

The Subsequent Call for Abstracts will invite submissions in the following categories:

- **1.** Scientific Research seeking original research from people doing the research, asking the questions, and working with the data that includes (but is not limited to):
  - Basic/bench science
  - Qualitative science
  - Observational science
  - Health services science
  - Clinical trials science
  - Dissemination/implementation science

Note:

- Scientific Research abstracts submitted through the Scientific Research Subsequent Call *require results* for submission consideration.
- Scientific Research Subsequent call abstracts will be reviewed by researchers and accepted and slotted by SOTS Chairs in collaboration with Assembly Co-Chairs.
- 2. Early Career and Professionals in Training Scholarly Works in Progress and Case



**Submissions.** Topics include original projects, novel care approaches, community-based initiatives, education innovations, implementation efforts, and interdisciplinary collaboration. *Note:* Scholarly Works in Progress submitted through the Early Career and Professionals in Training Subsequent Call **do not require final results** for submission consideration. Submitter Eligibility Definitions:

- Early Career Professionals: Up to five years post-training
- Professionals in Training: Currently enrolled in a formal education or training program Resubmission Note:
- 1. Abstracts submitted to the Principal Call that are not accepted may be resubmitted to the Subsequent Call, provided they meet Early Career Professionals in Training eligibility requirements.
