Maintenance of Certification (MOC) Points

The 2026 Annual Assembly of Hospice and Palliative Care is planned in the context of one or more of the ABMS/ACGME Competencies and includes an evaluation designed to assess changes in learners' competence, performance, or the impact on patient outcomes.

To support MOC reflection opportunities, the 2026 Annual Assembly offers end-of-day accredited education homerooms in the in-person space where learners engage with faculty and colleagues to share key learning points and discuss session reflections. Learners are asked to choose sessions reflective of their top learning priorities and to keep track of at least one key learning point from each attended session for reflective learning.

AAHPM has registered the 2026 Annual Assembly of Hospice and Palliative Care to offer MOC points to the following certifying Boards:

- American Board of Internal Medicine: Successful completion of this CME activity, which
 includes participation in the evaluation component, enables the participant to earn an
 anticipated 45 MOC medical knowledge points* in the American Board of Internal
 Medicine's (ABIM) Maintenance of Certification (MOC) program. Participants will earn
 MOC points equivalent to the amount of CME credits claimed for the activity.
